# **Report from Health Inspector Maria Schmitt:**

Maria mentioned that the first round of inspections is done for the restaurants and food trucks. The pool at Metropolitan has not opened yet, the inspection may be this week or next week. The YMCA camp pre-opening inspection is tomorrow.

C/Surak asked about the dogs on the report at the mobile home park.

Maria mentioned that there were 8 dogs at a home in Vanguard. Animal Control took the dogs to the shelter. The Police Department humane officer visited a few weeks earlier, but the dogs were not there. The owner wanted to keep them all, and may get some of the dogs back but Vanguard did not want any back. It was the same case on the report in May about the smell at the mobile home park. C/Surak asked about the dogs. Maria mentioned that they were all dalmatians, the owners kept the puppies. The Police Department humane officer investigated and Animal Control assisted on the case. M. Cinque asked about the inspections for daycare.

Maria mentioned that the Health Department inspects licensed daycares, and are licensed through the state.

M. Cinque asked about the food handler and manager compliance.

Maria mentioned it is included in the inspection sheet, and everyone has been fine. She will give out the class information if there is an issue, and information is available to take classes online or at the County.

## **OLD BUSINESS**

M. Cinque asked if there were any issues with the meeting schedule for the rest of the year. Secretary mentioned that the schedule was fine.

### **NEW BUSINESS**

Rabies Clinic-Secretary mentioned she will reach out to the vet to schedule a date in the fall. Flu Clinic- M. Cinque asked to let everyone know the dates of the Flu and Rabies Clinic when they are available.
