Report from Health Inspector Maria Schmitt:

<u>Bella Beauty Bar-</u> Since the report, Bella Beauty Bar moved down the street and received a new license. The building they were in was sold and they are now at 115 Moonachie Road. It is a bigger space and Maria went there to inspect.

<u>7 Henry Street Pool</u>- the pool is unkept and she will be writing a summons this week.

M. Cinque asked if the owner ever spoke to her or the Secretary.

Maria mentioned that they have never responded or answer the door when she goes there. The notice of violation was sent and they had 10 days to respond. Since then, she is still getting complaints from neighbors.

M. Mezzina entered the meeting at 7:45pm.

C/Surak asked about pests at Metropolitan which was on the report.

Maria mentioned that the office there need to get an exterminator because the issue is between certain mobile homes. When she went there the office was aware of the problem and was working on resolving it.

Maria mentioned that there was a complaint to the office about the workers not wearing gloves and were rude to the individual that was complaining. She mentioned that with pizza you do not need to wear gloves because it is going into the oven. An inspector went there was it was okay. Gloves do not need to be worn with raw food that is going to be cooked.

C/Surak mentioned that the person that had been feeding the cats on Jubilee is working with trapping the cats and finding homes for them.
