Report from Health Inspector Maria Schmitt:

Since the report, Enza opened and converted the hair salon to Bella Beauty Bar, and it was inspected. Paperwork was filed with the state and the Borough, she received the Borough license to operate. La Havana was conditional today due to some sanitation and fly issues. An inspector will to back to check in about a week.

M. Cinque asked about the COVID compliance assistance on the report.

Maria mentioned that when inspectors were going to restaurants, some of the time was logged as COVID due to going over the state guideline changes that were occurring.

OLD BUSINESS

Cat Feeding Ordinance: Attorney Moran spoke to Mr. Brynes at Animal Control who reviewed a previous draft ordinance. Mentioned that the Board of Health can pass the ordinance instead of the Mayor and Council. He had a question about any costs the town may incur going into the TNR program. Mentioned having some kind of ordinance in place even if it needs to be revisited or changed in a few months. The Board could review the draft over the summer and act on it in the fall.

M. Cinque asked C/Surak what the Mayor and Council had discussed about the Ordinance.

C/Surak mentioned that the Mayor would like the Board of Health to pass the Ordinance. Attorney Moran mentioned that he spoke to the Mayor and the Borough Attorney after the last meeting and they want the Board to pass the ordinance.

C/Surak asked when was the last time Attorney Moran spoke to the Mayor.

Attorney Moran mentioned that he spoke to the Mayor and the Board Secretary earlier today. He would like Animal Control to review the ordinance once more before the Board takes action. The Board discussed the ordinance and when to introduce the ordinance over the summer rather than in the fall.

M. Cinque asked Attorney Moran to send da final draft of the Ordinance before the scheduled July meeting via email.
