One of the best ways to get valuable work experience and learn about different career paths is through an internship! Several intern positions are currently available in the National Preparedness Division in DHS/FEMA Region II based in New York City. Interns will have the opportunity to work with FEMA employees as well as complete independent tasks and projects related to their field of study, whether it be economics, information science, public health, etc.

Raul Gomez, an intern currently enrolled at NYU's Wagner School of Public Service, participated in Gotham Shield 2017 doing evaluation and design analysis, as well as developing a presentation for the Active Shooter workshop series. Across the hall in another division, Stephen Swain aided the Region



II Exercise Officer in "developing full scale, functional, and tabletop exercises for a range of different audiences." Though initially unsure of what department he preferred, "being involved with exercise design, I fell in love with it. I am happy to say that I have made it a career." Stephen is now working as a full time exercise and training consultant for a state agency.

While working on these projects for FEMA, students also hone professional skills to be applied at FEMA in the

future or any workplace after the internship. Nathan Psota says that "while working with FEMA as an intern, I learned background information on emergency management, presentation skills, and gained experience in a collaborative environment"—expertise that he now uses every day in the Program Management Branch of the Mitigation Division in FEMA, Region II. Julia Roberts also interned at FEMA, commuting 2.5 hours each way, and has followed her passion by working with mitigation and recovery for the past decade. Ruth Holiday, who currently works in health care but hopes to return to emergency management, says her time at FEMA helped her to develop and improve upon her professional



communication skills, writing ability, and research skills. Her time spent researching and compiling

resiliency projects in New Jersey utilized all of these skills in order to present a toolkit now distributed throughout New Jersey in order to better prepare communities. With interns coming from a variety of backgrounds with even more diverse career goals, FEMA aims to help students learn modern emergency management techniques as well as introduce them to the day-to-day challenges and triumphs of working in public service.

### Individual and Community Preparedness

The Community Preparedness Intern will work under the supervision of the Community Preparedness Officer and/or the Integration Branch Chief, the intern will provide research, planning, and development of a series of preparedness programs. This graduate or undergraduate level internship will provide the student with an opportunity to gain experience in the Federal Government, Emergency Management, Community Development, and Partnership Coordination. The Community Preparedness Intern will also support the Community Preparedness Officer to plan, initiate, coordinate and execute the development of a Higher Education Preparedness Network, which will meet the needs of Region II states New Jersey and New York to build and support successful preparedness efforts.

### **Continuity of Operations**

The Intern will support the Continuity Manager to help coordinate and manage the continuity of operations program for Federal, State level (New Jersey, New York, Puerto Rico and Virgin Islands) and tribal, local governments within Region II states. The intern will help the Continuity Specialists build continuity programming between FEMA and the Continuity of Operations Working Groups (CWG) and will help organize, manage and facilitate training and exercise events, write policy papers, evaluate programs, develop plans, conduct outreach, instruct classes help identify gaps or weaknesses in pandemic and cyber security planning policies procedures and attend meetings.

### Requirements

(1) Interns MUST be enrolled in a Graduate School or Undergraduate School in their Junior/Senior year.

(2) Previous work or ongoing study at bachelor's level in public health, liberal arts, business, public administration, communications, training, economics, emergency management or public relations.
(3) Interns must be United States Citizens only (green card holders or those with student visas/work permits are not allowed).

(4) Accepted Interns must complete a background investigation and suitability of employment prior to start date (this process can take 4-6 weeks or longer).

### **Exercise Design Course**

The New Jersey Courts and the Federal Emergency Management Agency (FEMA) Region II will be conducting training for emergency exercise design and evaluation (a combination of FEMA Courses I-120 and L-146). The course is a 4 day program which focuses on the design phase of the Homeland Security Exercise and Evaluation Program (HSEEP).

### Course details:

Emergency managers, emergency services personnel, and other individuals who are part of the emergency preparedness and response or continuity of operations need to be able to use the fundamentals of exercise simulation and design as an integrated system of resources and capabilities. Skills learned during this program will enable jurisdictions to conduct NIMS required exercises.

The course will develop emergency response and continuity exercise skills in the following areas:

- · Exercise programs
- $\cdot$  Exercise design steps
- · Exercise evaluation
- $\cdot$  Designing a functional exercise

- · Exercise process
- · Tabletop, functional and full scale exercises

The course will conclude with students conducting and evaluating actual tabletop and functional exercises in a group/team environment.

# FEMA Region II Preparedness Webinar: Preparedness Planning for Senior Citizen Communities

**Description:** The senior citizen population faces several unique challenges, coupled with the fact that many are often dependent upon others for basic necessities and psychosocial support. This dependency often increases their vulnerability to the impacts of major disasters, when not only are the seniors themselves impacted, but these critical services are also disrupted. Currently, 46.2 million people in the United States are 65 years old or older, with that number expected to increase each year. This population demographic made up 13.3% of the population in the 2011 Census. The ability to recover from an emergency tomorrow often depends on planning and preparation done today. This webinar will provide to older individuals and their caregivers, as well as to the local agencies who serve them, tools and information to assist them in assessing their needs and vulnerabilities so they can be better prepared to cope with emergencies.

**Speakers: Ms. Kathleen Otte** is the Regional Administrator for HHS Regions I and II for the U.S. Administration for Community Living (ACL). In this capacity, she represents the Administration and the Assistant Secretary on Aging on all matters related to the implementation of the Older Americans Act (OAA) and other aging related issues within the 8 states and 2 territories she oversees. Prior to joining AoA, Kathleen served as the Director of the Bureau of Elderly and Adult Services for the State of New Hampshire. Kathleen and the New Hampshire team designed and implemented a caregiver support program that received national distinction by winning the Regional Innovation Award from The Council of State Governments and developed the nation's first statewide 'Structured Decision Making' process for Adult Protective Services.

Kathleen has over 30 years' experience in the field of aging, having served or volunteered in various human service delivery programs. In 2014, Kathleen received the Spirit of Jane Addams Award for Outstanding Performance in Social Justice from Be the Evidence, International for her work with Elder Justice Initiatives.

**Rhonda Schwartz** is an Aging Services Program Specialist within the U.S. Department of Health & Human Services Administration for Community Living. Rhonda is assigned to the Regional Office located in Boston, MA, where she works with federal, state and tribal organizations in the region, with particular attention to oversight of the Older Americans Act state and tribal grant programs. Prior to joining ACL in July 2016, Rhonda spent more than seven years managing Older Americans Act and other ACL programs at the Rhode Island Division of Elderly Affairs. Rhonda previously practiced law for sixteen years, specializing in commercial real estate transactions, before pursuing a Masters Degree in Social Work, focusing on older adults.

# Daniel Craig and Daniel Kaniewski Nominated for Leadership Positions at FEMA

Last week, President Trump announced his intent to nominate Daniel Craig and nominated Daniel Kaniewski, both outstanding individuals, for leadership roles at the Federal Emergency Management Agency (FEMA) within the U.S. Department of Homeland Security. If confirmed, Daniel Craig would serve as the Deputy Administrator of FEMA and Daniel Kaniewski would serve as the Deputy Administrator of Protection and National Preparedness.

Mr. Craig is a Senior Vice President at the disaster preparedness and recovery and insurance consulting firm, Adjusters International, Inc. He has also served as the CEO and president of Tidal Basin Holdings, a company he founded. There, he oversaw operational companies working in the emergency management planning, disaster recovery, and mitigation industry. Mr. Craig has also previously held positions at FEMA, serving as both the Director of Recovery and the FEMA Regional Director for the New England area. He recently served as Chairman of the Board for the Disaster Recovery Coalition of America and an assistant adjunct professor of homeland security and emergency management at the University of Maryland University College.

Dr. Kaniewski is Vice President for Global Resilience at AIR Worldwide, a catastrophe risk modeling and consulting services firm. He is also a Senior Fellow at the Center for Cyber & Homeland Security, where he contributes thought leadership on homeland security and emergency management topics. Prior to these positions, he served as the Mission Area Director for Resilience and Emergency Preparedness/Response at the Homeland Security Studies and Analysis Institute (HSSAI).

## FEMA Tribal Outreach and Consultation Period on FEMA Tribal Consultation Policy

FEMA will initiate a 90-day outreach and consultation period from **June 1 to August 29, 2017**, to seek input from federally recognized Indian tribal governments on the update of the agency's Tribal Consultation Policy. The <u>FEMA Tribal Consultation Policy</u>, first issued in 2014, acknowledges the agency's nation-to-nation relationship with tribal governments. The policy also guides how FEMA engages tribal governments in regular and meaningful consultation and collaboration on policy and actions that have tribal implications.

This consultation period aims to update the policy to reflect current authorities and best practices, as well as follow FEMA's new policy document format requirements. FEMA seeks input and feedback from tribal leaders, or their designees, during the consultation period to help inform the development of an updated policy.

# **Important Deadlines**

## **Apply for the 2018 National Emergency Management Executive Academy**

FEMA's EMI is now accepting application packages for the 2018 National Emergency Management Executive Academy. Ideally, candidates will have experience as senior executives of major emergency management organizations, served on major commissions and task forces, or be responsible for decisions that have a significant effect on homeland security and emergency management policies.

# Comments Needed for Draft Policy on Floodplain Development

FEMA prepared a draft policy for FEMA staff and communities participating in the NFIP to update guidance for participating communities on satisfying National Flood Insurance Program (NFIP) floodplain development permit requirements, and to address questions about floodplain permitting of development activities occurring in the FEMA designated Special Flood Hazard Areas (SFHA). Through this policy, a community can ensure compliance with NFIP and local floodplain management regulations, while potentially reducing the administrative burden associated with permitting certain types of low-to-no impact development in the floodplain.

This guidance does not intend to address other permits associated with building codes, or other federal, state, local, tribal, or territorial permits, and only applies to floodplain development permitting requirements to enroll in, and maintain eligibility for, the NFIP. The draft policy is available for review on FEMA's website at: <u>https://www.fema.gov/media-library/assets/documents/131010</u>, and the public is invited to provide comment and input via <u>FEMA-Floodplain-Management-Division@fema.dhs.gov</u> until **August 23, 2017**.

This VTTX differs from other tabletop exercises in that it will be conducted using Video-Teleconference (VTC) technology (not a web-based program), and is intended to provide an opportunity for responders across the Nation to simultaneously participate in a hazard-specific facilitated discussion. Lead facilitation for the exercise will be coordinated by EMI, with local facilitation provided by the participating agency.

# **Cyber Do's and Don'ts for Summer Travel**



Summer is in full swing, and millions of Americans are planning their summer getaways. These days, we can't imagine traveling without mobile devices to help us navigate new cities, find local restaurants and shopping centers, and share photos with our friends and family back home. But the more we rely on our mobile devices, the more we expose ourselves to cyber threats as we travel.

As you're prepping for your summer vacation or family trip, remember to protect yourself online when you're on-the-go. Travelers are prime targets for cyber

criminals, so don't let your trip be ruined by cyber crime. As you travel this summer, the <u>Stop.Think.Connect.TM Campaign</u> encourages you to keep in mind these cyber do's and don'ts:

- Do:
  - Back up your information: make backup copies of your contacts, photos, videos, and other mobile device data on another device or cloud service in case your device is stolen, lost, or compromised in some way.
  - Lock down your login. Enabling strong authentication such as multi-factor authentication that uses a one-time code texted to a mobile device to confirm your identity – on your sensitive online accounts will give you an extra layer of protection from hackers.
  - Be wary of travel deals. Look out for deals that look too good to be true, coupons offered on social media, and smartphone app scams. If you aren't sure a deal is real, check to see if you're using a trusted website or call the company directly to verify.

### **Do NOT:**

- Leave your device unlocked. It only takes a couple seconds for a thief to steal your device. Locking your device with a strong PIN, password, or fingerprint ID will help keep your data safe.
- Share your location. Many apps and devices use geotagging and location sharing to broadcast your location publicly. Make sure that these settings are off to prevent criminals from knowing where you are. Also, check your privacy settings on social media sites.
- Trust public Wi-Fi. Many vacation spots and other public places offer free Wi-Fi networks, which are usually not very secure and can allow cyber criminals access to your Internet-enabled devices. Be careful when connecting to free Wi-Fi, and don't do any online banking or shopping while on a public network.

# Preparedness for People with Disabilities and Others with Access and Functional Needs

The 27th anniversary of the <u>Americans with Disabilities Act</u> is Wednesday, July 26. Individuals and caregivers for people with disabilities and others with access and functional needs are encouraged to evaluate their necessities in the event of an emergency and <u>create an emergency plan</u> unique to them.

Some easy ways to create an emergency plan tailored for specific needs:

- Collect information Create <u>a paper copy of the contact</u> <u>information</u> including phone, email, and social media information for your family, friends, caregivers, neighbors and other important people or service providers.
- Share your emergency plans Tell your employer and trusted people in your support networks where you keep your emergency supplies, what you need, and how to contact you if the power goes out.
- Practice Your Plan Dedicate time to practice your emergency plan with your support network, just as you would with a fire drill.

### Greater Impact: How Disasters Affect People of Low Socioeconomic Status

### Disaster Information Management Research Center.

This 20-page study focuses on how people in poverty, with low incomes, and of low socioeconomic status experience disasters. It explores the differences in risk perception and disaster preparedness, response, and recovery. Although it provides some information on international disaster events, it is primarily focused on disasters that have affected communities within the United States. Research suggests that people of differing socioeconomic statuses may prepare for a disaster differently.
