DISCUSSION:

1. New DPW Building Construction.

Mayor Vaccaro mentioned that the contractor has not submitted any documents for final payment and the Borough has not received any closeout documents. Mentioned speaking with Attorney Migliorino, the bonding company and that until the project is closed the warranties are not in effect. Mentioned that the architect reached out to the contractors and the garage door subcontractor will not come back until they are paid in full by the contractor.

C/Kinsella asked about a grand opening for the building.

Mayor Vaccaro mentioned it would be sometime in the summer.

C/Martinez asked if the old building will be used.

Mayor Vaccaro mentioned that some of the equipment is still there because it cannot be moved yet until they get the lift equipment, they still need the old building to service trucks

C/Martinez asked if the dumpsters will stay there.

Mayor Vaccaro mentioned the dumpsters will stay at the old location until a fence is installed at the new site, once everything is set up, they can schedule a day for drop offs.

- 2. Traffic Light between Moonachie Road and Moonachie Avenue. Mayor Vaccaro mentioned that he has to contact the County on the status, and they did put in for funds through the NJSEA, but it was rejected. Mentioned that the Attorney for the Mayor's Committee said they should fight the decision.
- 3. Energy efficiency for Municipal Building. Borough Clerk mentioned that the RFP's are being received next Friday.
 - 4. Moving Court to Municipal Building.

Mayor Vaccaro mentioned that the individual that was out will be back within the next two weeks, the work has been approved and includes switching the TV and wiring.

5. Backflow Preventor Site Access Agreements Due June 10th. Mayor Vaccaro mentioned that he reviewed the project, the County had received money after Hurricane Sandy from FEMA, and backflow preventors were going to be put in Little Ferry, Moonachie and Carlstadt, the town got easements from property owners but they have expired. Also, he mentioned that the County wants the towns to get new easements so they can finish the project,the project needs to be started by September 1st. He spoke to the County today so that they can get the agreements that the County had before for the properties, so that they can get new easements. Mentioned that once the project is completed the Borough is responsible to maintain the backflow preventors.

Administrator Ciannamea entered the meeting at 7:19 P.M.

6. Clean Communities Grant/Coordinator.

Mayor Vaccaro mentioned that the Borough currently does not have one and needs to be appointed. Mentioned that reports for the past 3-4 years need to be completed and signed off, but the previous Coordinator is not here anymore.

7. Police Department.

Mayor Vaccaro mentioned that the lieutenant retired last year, and spoke about requesting a list.

Mentioned speaking to the Police Chief and DPW regarding the traffic situation at the school, and buses going around the back of the school.

Mayor Vaccaro mentioned it is an option to have it one way during school hours, but unless the cars pull up there, it will not make a difference with traffic. Spoke about the traffic being backed up on Park Street, and mentioned if there is an emergency on Park Street that could be a problem.

C/Martinez asked about illegal registration at the school.

C/Kinsella mentioned the school checks the residency on registration.

Administrator Ciannamea mentioned about involving the kids in Clean Communities. Mayor Vaccaro spoke about the park clean up project in July.
