## **Report from Health Inspector Maria Schmitt:**

Maria spoke about the Governor's Executive Order that will go into effect this week. Restaurants will have to close for indoor dining at 10pm. Spoke about report from last month, El Tango had bubbles in the outdoor dining but were taken down because there were not allowed. Beginning Thursday, they will be able to use them again. She will go there to speak to the owner about it.

Maria mentioned about the issue with Enza's Salon wanting to do microblading. The owner was certified, but the state Board of Cosmetology does not allow it to be conducted at the same establishment with another license. Spoke about if it had been allowed by the state, Moonachie would need to have an ordinance to license the business, which would fall under body art, tattooing and piercing.

C/Surak asked if the owner was the one going to do the microblading.

Maria said yes, that she has the certification. Mentioned that Moonachie has to allow the business, and that it was approved through building and zoning. And in an ordinance, the town can set what zone the business is allowed in.

M. Cinque asked if they should do an ordinance.

Maria mentioned that they should do it, because it will likely come up in the future. Spoke about example from another town she is in.

Attorney Moran explained that he would need to discuss with the Building and Zoning Department and forward any draft ordinance to the Mayor and Council. Mentioned about the state's requirements for body art.

M. Cinque asked Attorney Moran to look into the topic and draft an ordinance.
