#### **Report from Health Inspector Maria Schmitt:**

Since the report, there is a new owner at Prova; it was satisfactory at inspection. There was a dog bite at 57 Edstan Drive, it is the 3<sup>rd</sup> time the dog has bitten someone. Animal Control went to Court for this dog before. The Police went to the home and no one answered. Animal Control will impound the dog and go to court again. The rabies vaccination for the dog is fine.

M. Cinque asked about feeding cats on the report.

Maria called the person who complained and explained to them about the traps from the County. The person has to set the traps. It was two different addresses in the same area on the report, one on Diamond Way and the other on the back of Joseph Street. M. Cinque asked if something could be put in the Messenger about feeding animals. M. Cinque asked about complaint of cockroaches in Metropolitan.

Maria mentioned that a neighbor called about a home, Maria went to the office and Metro was going to send the resident a letter that their home needs to be treated.

Maria mentioned that the complaint about the dumpster was fine when she went past. La Havana and Berry's Creek were conditional but were fine at reinspection. The pool at Metro needed to be closed once, but was fine after the pump was replaced. It is better that the CPO is a resident at Metro.
