He mentioned because of Mayor's Committee, the Borough does not have to pay Tax Sharing payment.

Mr. Sachs- spoke about the ADA Ramp Program, that Borough sent a Purchase Order but Reggio notified Boswell that the contract with the County has to be amended. He mentioned that the curbs have to be done first before the road can be paved. Mayor Vaccaro -mentioned that the Borough is going out to bid on February 19 for the

Mr. Sachs -spoke about the MS4 Mapping, Boswell was advice that there are more outfalls and another \$4,200 will be needed for the other 29 outfalls, which was sent in a proposal to the Borough. He mentioned that the mapping needs to be done before the brush starts growing.

He mentioned that West Commercial Avenue project plans and specifications were sent to NJDOT and already received comments. He mentioned that the plans have to be sent to Trenton due to rail road tracks.

Mayor Vaccaro- mentioned about seeing emails regarding easements.

Mr. Sachs- mentioned that the temporary easement will be four properties. He explained that the right-of-way width 40ft, outside of the pavement is on private property, curb need to be replaced, a DOT requirement to put a guard rail, where there is a boulder there, which is an obstruction and two existing "A-Inlet" need to be clean.
