# **DISCUSSION:**

1. New DPW Building Construction (Awarded Bid of Tricon Enterprises, Inc. in the total amount of \$2,512,000.00).

Mr. Sachs- mentioned that the Mayor had a meeting with the Contractor and the bid was awarded to for the DPW Building.

Mayor Vaccaro- mentioned that the Port Authority wants Phase 1 to be completed and signed off before Phase 2 starts. He asked Mr. Sachs whether the letter from LSRP will be done after Phase 1.

Mr. Sachs- explained that the RAO letter from LSRP will be done after Phase 2, which will be installation of the building, roadway and landscaped areas.

Mayor Vaccaro- mentioned that the Contractor has to notify about the details of the project and Phase 1 of the project has to be approved by the Port Authority before Phase 2 can start. Also, he mentioned that the Port Authority has to attend the preconstruction meeting. He asked Mr. Sachs to find out if couple of months gap between Phase 1 and Phase 2 will be an issue.

Mayor Vaccaro- mentioned that he has a meeting with Tricon and he asked the contractor about their experience with construction. Asked Attorney Migliorino to make sure that the contractor knows about working with the Port Authority and the time frame for the project.
