PUBLIC HEARING:

Sal DeAlessandro, 1 Frederick Street- asked about the bond ordinance for \$75,000 in December for improvements to the intersection at Moonachie Avenue and Moonachie Road and he asked whether intersection improvements and traffic light at Moonachie Ave. & Moonachie Rd. two different project.

Administrator Ciannamea mentioned that the Boswell's bills for the traffic light will be coming out of that bond ordinance.

Mayor Vaccaro – mentioned that intersection improvements and traffic light will be same project.

Mr. DeAlessandro -asked about testing at Hain Celestial.

Mayor Vaccaro- mentioned that he is having a meeting with Hain Celestial tomorrow.

Mr. DeAlessandro- asked about escrow money of 25,000 from Hain Celestial.

Attorney Migliorino mentioned that Hain Celestial does self-testing and will have their numbers to compare with the testing the Borough does. Also, he mentioned that he will have numbers from BCUA and the money from escrow has been used for cleaning the line.

Mayor Vaccaro- mentioned that there will be discussion about the problem at Hain Celestial at the meeting and they are working with the Borough.

Mr. DeAlessandro -asked about all the streets that are not being brined.

Mayor Vaccaro mentioned that all the main roads are brined when a storm is coming. C/Bauer mentioned that the brine would need to be refilled to do the secondary roads, but there is no place to store the brine, if there was a large enough storm the secondary roads could be brined.

Mr. DeAlessandro -spoke about the salt on the roads affecting runoff. Mentioned about the conditions of Route 46 with potholes.

C/Bauer -mentioned that Superintendent Lyons has called the State three times regarding the potholes there and by the overpass.

Mr. DeAlessandro -spoke about the ongoing problem with a leak in the firehouse roof since November. He has contacted VMG that did the roof. He asked about the Bond with the contractor.

Mayor Vaccaro- mentioned that the maintenance bond with the contractor is for two years and the warranty for the roof should be 20 to 25 years.

Mr. DeAlessandro-mentioned that VMG filed a claim with GAF and he went through multiple people in claims trying to get the problem resolved. Spoke about what GAF has asked for various pictures and an estimate of the repairs.

Mayor Vaccaro- suggested that the roof should not be fixed by anyone without certification.

Mr. DeAlessandro- mentioned that he got the estimate from the same person that installed the roof and the estimate for the repairs came to \$4,236.00. He asked for direction to go forward with the repairs.

Mayor Vaccaro- asked Mr. DeAlessandro for the claim number so he can contact GAF and asked his to get a quote with labor and materials separately.

Barbara Mendola, 27 Union Street- mentioned that she wants to start a book club in Moonachie because there is no library available for residents and she asked for an office in the Borough hall.

Mayor Vaccaro- asked whether she spoke to the school. He mentioned that she should reach out to Superintendent Dr. Ponds because School already has a library.

C/Kinsella -mentioned that the school is open on Saturday mornings for Saturday School and she asked about the responsibility of book club.

Ms. Mendola- answered that she will be responsible for it.

C/Bauer- mentioned that there would need to be more people to help if Ms. Mendola is not available.
