## **PUBLIC HEARING:**

Noelle Werdann, 5 Henry Street- asked about ordinance for commercial trucks in residential areas.

Mayor Vaccaro -mentioned that there are Ordinances for parking on the street based on the weight of the truck.

Mrs. Werdann- mentioned that there is a staples box truck that is parked in the street or in the driveway overnight & the weekends for the past few months.

Mayor Vaccaro- mentioned that she can contact the Police Department, and they can look into it.

Mrs. Werdann- mentioned that she does not want to see truck in front of her home. Mrs. Werdann- presented pictures to the Mayor and Council of the conditions of her neighbor's property. She mentioned that there is water in the pool and thing are growing in there, she had brought the issue up to the Council last year. She spoke about the building in the backyard that is falling down, and there is garbage, very high grass, weeds and poison ivy. She spoke about mosquito problem when her granddaughter goes outside.

Mayor Vaccaro- mentioned that the Construction Official was at the property last year and he will bring this to his attention, and to the Property Maintenance Official.

Mrs. Werdann -spoke about cars in the driveway and garbage at her neighbor's property. Barbra Mendola, 27 Union Street- spoke about Book Club, and finding the right location for it in Moonachie.

Mayor Vaccaro- mentioned that the Book Club can be at the School because the school has a library.

Mrs. Mendola- explained that she has about 300 books, there was not enough space for them to store at the school and she will need three double sided book cases at the Borough Hall for the books. She mentioned that the people will come on Saturday for

Book Club.

Attorney Migliorino- invited Mrs. Mendola for the Grand Opening of the Borough Hall. Mayor Vaccaro -mentioned that he will call Dr. Ponds and try to work something out. Mrs. Mendola- asked if there are adequate police officers to cover the town, and whether the Borough will hire more when current officers retire soon. Also mentioned that she has not seen any patrols near the west side of town where she lives.

Mayor Vaccaro mentioned that three police officers were hired last year, there is enough police officers for coverage, and he will speak to the Police Chief about patrols on the west side of town.

Mrs. Mendola spoke about air quality in town. Mentioned that she was short of breath, needed to stay in the hospital five days and her neighbor also had the same symptoms. She expressed her concern about the airport. She mentioned that she called

Environmental Protection to check the air quality and she heard that Jets are dumping fuel in Moonachie.

She spoke about garbage piling up near mobile homes in Metropolitan, and the homes are too close to each other and if there is a fire, it would spread.

Mayor Vaccaro- mentioned that there is no proof of fuel dumping by the Jets. He spoke about climate changes. He mentioned that Metropolitan does have regulations regarding space between homes and they need to get permits from the town for any work that has been done.

Attorney Migliorino- mentioned that Met Park is very strict on the people who lived there.
