Motion by R. Petrella and second by N. Derevyanik to adopt the minutes of the Regular Meeting of November 20, 2018(no meeting in December, 2018).

Seven ayes, one abstain. Motion carried.

COMMUNICATIONS:

Supriya Sanyal, Borough Clerk- notification of 2019 appointments of members to the Planning Board.

Bergen County Soil Conservation District- notice of certification of Soil and Sediment Control Plan for underground conduit at Moonachie Avenue.

Borough of Moonachie (Mayor and Council)- requesting Planning Board to review, to report and to recommend on the draft proposed Ordinance regarding Medical Marijuana Uses.

Motion by V. Drozd and second by N. Derevyanik to file communications. ROLL CALL: Molinari, Derevyanik, Campbell, Meehan, Drozd, Lyons, Arroyo, Petrella. All ayes. So ordered. REPORTS: None

OLD BUSINESS:

M. Lyons- spoke about the communication item regarding certification of Soil & Sediment Control Plan. She mentioned that this certification is for Public Services, she will have a meeting with Public Services and she will find out more about the location of the conduit being placed.

Secretary mentioned that it was already approved.

M. Lyons -reviewed communication and spoke about the conduit being able to help the industrial areas which use a higher volume of electricity. She mentioned that PSE&G started from Carlstadt, going through South Hackensack up to Teterboro Landing.

J. Campbell- asked about Airbnb, mentioned that he saw an increase over the holidays with people wanting to go into New York City.

M. Meehan- felt that people should have to come before the board to get a change of use. J. Molinari -mentioned that there was no consensus with the board at the last meeting. J. Campbell- spoke about registration requirement for Airbnb in Bradley Beach for each rental.

Secretary- mentioned that the Mayor and Council discussed the Ordinance, the Council felt that the it should not be allowed at all and the Ordinance Committee is reviewing now. J. Campbell- mentioned about his issues unknown people coming to stay for Airbnb, and it can affect real estate values. Spoke about differences with homes being rented in Bradley Beach. He- suggested letting the Mayor and Council know the Board's concern.

J. Molinari- mentioned that a concern was who polices the issue.

Attorney Novello- mentioned that the Board was presented the proposed Ordinance for Airbnb by the Mayor and Council, the Ordinance was to provide legalization of Airbnb with stipulated fees and with couple of regulatory items. He spoke about overtone of the Board about this ordinance and the reason for tabling the Ordinance. He recommended for the Board not to do anything at this time and he mentioned that the revised Ordinance may be presented to the board.

M. Meehan- asked what other towns are doing?

Attorney Novello- mentioned that similar to medical marijuana, many towns are regulating or outright banning Airbnb. Commented that either way enforcement of the Ordinance would not be through the Planning Board or the Mayor and Council, it would be through inspectors and the zoning code official allowing or not allowing Airbnb. He mentioned that someone would have to follow up on the complaint.

M. Lyons- asked about the number of Airbnb in the town.

J. Molinari- mentioned that there are three Airbnb in town.

M. Lyons- confirmed that there is no complain to the Police Department and there is no parking issue due to Airbnb. She mentioned if the Borough flat out say no to Airbnb, people will still try to get around it, and there should be structure.

Attorney Novello- mentioned that the structure will be good if it is enforced.

M. Lyons- mentioned that the registration fees will pay for the inspector for enforcement. Attorney Novello- mentioned that registration fees alone will not be enough for an inspector, and that the short-term rentals are not prohibited, but illegal occupancy is. He explained about legal short-term rentals.

M. Meehan- mentioned that he has to pay \$125 for C.O. for each time there is change of renter. N. Derevyanik- mentioned the renter can sue the owner and the town if something happens due to lack of insurance for short-term rental. He suggested that people can get a special type of homeowner's insurance policy for Airbnb. Spoke about a lack of manpower to enforce the proposed ordinance and to enforce illegal homes currently.

The Board discussed not supporting Airbnb in Moonachie.

Attorney Novello- mentioned the Board is not in favor of Airbnb due to planning and zoning issues.

J. Molinari- asked if any members are in favor of Airbnb.

M. Lyons- answered that she does not have any problems with Airbnb, and mentioned that Airbnb cannot be stopped without legal framework.

Attorney Novello- explained that the Board does not determine whether Airbnb is legal or illegal, but the Mayor and Council would have power to draft the Ordinance, and the proposed draft ordinance to legitimize Airbnb that was given to the Planning Board for review. He mentioned that the Board is not in favor of legitimizing Airbnb.

M. Lyons- asked if the town will be protected.

Attorney Novello -mentioned that the Borough Attorney would need to determine if the town will be protected.

M. Meehan -asked if the Borough can have an Ordinance to prohibit Airbnb.

Attorney Novello- mentioned that the Ordinance to prohibit certain rentals can be done, but the Ordinance can be challenged. He explained that the Ordinance could be for restricted provision for Airbnb and the requirement can be for the insurance. He mentioned that there could be a penalty for violations.

N. Derevyanik -asked whether the Meadowlands Commission can override this Ordinance. Attorney Novello- mentioned that the Meadowlands Commission does not have jurisdiction in residential areas. He suggested to send a letter to the Mayor and Council regarding the Board's concerns and to request to provide any revised Ordinance to the Board for review.

M. Lyons- mentioned that the Ordinance should be done to protect the town.

J. Campbell -mentioned that he saw 15 people at an Airbnb, there are two by his home, and one by Joseph Street.

N. Derevyanik- asked about the process after the Committee reports back to the Mayor and Council. He was told that the Ordinance will be a draft. He confirmed that the people can come to the meeting to voice their opinion.

Secretary- mentioned that the Ordinance will be advertised and prior to the adoption of the ordinance and there will be a public hearing.

M. Lyons -suggested that the Board should be notified prior to the introduction of the ordinance.

Secretary -mentioned that the draft letter will be email to the Board members to review.

Motion by J. Molinari and second by J. Campbell to authorize secretary to send a letter to the Mayor and Council about the Planning Board's opinions on the Short-Term rental Ordinance (proposed).

N. Derevyanik- asked about the time frame of the report of the committee. He was told that the Ordinance is a discussion item on the monthly Executive Meeting Agenda.

Motion by V. Drozd and second by N. Derevyanik to adjourn meeting at 7:55 P.M. ROLL CALL: Molinari, Derevyanik, Campbell, Meehan, Drozd, Lyons, Arroyo, Petrella. All ayes. So ordered.
